PRINCIPAL INDUSTRIES IN COVINGTON AND ESCAMBIA ARE OIL, AGRICULTURE, LIVESTOCK AND FARMING. THIS COUNTY IS PREDOMINANTLY RURAL IN NATURE.

THERE ARE NO OTHER PERTINENT DEMOGRAPHIC FACTORS TO ESCAMBIA COUNTY; HOWEVER, THE STATE OF ALABAMA HAS A MAXIMUM SECURITY PRISON LOCATED OUTSIDE OF ATMORE, ALABAMA. THE STATE OF ALABAMA PRISON SYSTEM THEREFORE EMPLOYS MANY INDIVIDUALS OF ESCAMBIA COUNTY, ALABAMA.

THE FOLLOWING IS A THREAT ASSESSMENT RELATIVE TO PIKE COUNTY, ALABAMA:

MARIJUANA CULTIVATION IS COMMON ON THE FEDERAL LAND. THE COUNTIES, STATE POLICE AND DRUG ENFORCEMENT ADMINISTRATION (DEA) ARE ENGAGED IN A MARIJUANA ERADICATION PROGRAM.

THERE IS INFORMATION INDICATING THAT MOTORCYCLE GANGS ARE ENGAGED IN MANUFACTURE AND DISTRIBUTION OF METHAMPHETAMINE OR "SPEED." THE GANGS ARE ALLEGED TO CONTROL THE WEST COAST DISTRIBUTION OF SPEED.

THERE ARE SURVIVALISTS AND POSSE COMITATUS MEMBERS IN THE TWO COUNTIES. IN MEDFORD THERE IS A GROUP WHICH IS RELATED TO THE POSSE COMITATUS WHICH IS CALLED THE CITIZEN'S BAR ASSOCIATION. LIKE THE POSSE, THEY ARE OPPOSED TO PAYING FEDERAL INCOME TAXES, COMPLYING WITH DMV LAWS, AND ARE GENERALLY ANARCHISTIC IN PHILOSOPHY.

BY REFERENDUM, A MAJORITY OF THE VOTERS OF THE CITY OF ASHLAND DECLARED THEIR CITY A "NUCLEAR FREE ZONE." THE GENERAL POPULATION IS VERY SENSITIVE TO THE SUBJECT OF NUCLEAR WAR. THE VOTE TO MAKE THE CITY A NUCLEAR FREE ZONE TENDS TO REFLECT A DISAPPROVAL OF U. S. GOVERNMENT POLICY ON NUCLEAR WEAPONS.

THE MAJOR CITY IN THIS COUNTY IS ROSEBURG. MUCH OF THE COUNTY IS WILDERNESS AND OWNED BY THE U. S. GOVERNMENT. THE MANUFACTURE AND DISTRIBUTION OF METHAMPHETAMINES UNDER THE CONTROL OF MOTORCYCLE GANGS OCCURS IN THIS COUNTY. THERE HAVE BEEN INSTANCES OF DRUG SMUGGLING ON THE OREGON COAST AROUND THE DOUGLAS COUNTY COASTLINE. MARIJUANA CULTIVATION ON GOVERNMENT LAND IS REPORTED.

THERE ARE PEOPLE WHO ARE ACTIVE IN POSSE COMITATUS AND AMERICAN FREEMEN ASSOCIATION. THERE ARE ALSO SURVIVALISTS. NONE OF THESE HAVE POSED A PROBLEM TO LAW ENFORCEMENT IN THE AREA TO DATE.

THERE IS A SMALL COAST GUARD RESCUE STATION ON THE COAST AT REEDSPORT AND NO OTHER MILITARY PRESENCE. THE COUNTY IS CLOSED TO CRITERIA COUNTRY OFFICIALS BY STATE DEPARTMENT REGULATIONS.

UNION COUNTY.

LA GRANDE, OREGON, IS THE LARGEST TOWN. THERE IS SOME METHAMPHETAMINE MANUFACTURING. A LABORATORY WAS FOUND, AND THE PEOPLE ASSOCIATED WITH IT WERE PROSECUTED ABOUT A YEAR AGO. THERE IS NO MOTORCYCLE GANG ACTIVITY OR ANY

OTHER FORM OF ORGANIZED CRIME. THERE IS NO CULTIVATION OF MARIJUANA. THERE ARE NO MILITARY INSTALLATIONS.

THERE IS SURVIVALIST ACTIVITY WITH REPORTS OF WEAPONS PRACTICE IN REMOTE AREAS. ALTHOUGH THERE IS NO KNOWN POSSE COMITATUS ACTIVITY, THERE MUST BE SOME.

THERE IS A LARGE MEXICAN POPULATION INCLUDING BOTH RESIDENTS AND TRANSIENT PICKERS. WHILE THERE IS SOME CRIMINAL ACTIVITY ASSOCIATED WITH THIS ETHNIC GROUP, IT IS NOT UNUSUAL OR A SIGNIFICANT LAW ENFORCEMENT PROBLEM. THERE ARE NO MILITARY FACILITIES.

MALNEUR COUNTY.

THERE IS NO DRUG CULTIVATION OR ACTIVITY IN THIS COUNTY RELATIVE TO MOST OTHERS.

THERE ARE NO MILITARY FACILITIES IN THE COUNTY. THERE IS NO ORGANIZED CRIME OR SIGNIFICANT CRIMINAL ACTIVITY ASSOCIATED WITH ANY PARTICULAR GROUPS. THERE IS A LARGE POSSE COMITATUS AND SURVIVALIST ELEMENT AMONG THE POPULATION.

LANE COUNTY.

LANE COUNTY INCLUDES THE CITY OF EUGENE, THE SECOND LARGEST CITY OF THE STATE THAT CITY HAS THE USUAL AMOUNT OF NARCOTICS AND OTHER CRIMINAL ACTIVITY, INCLUDING GAMBLING. THE CLOSEST TO ORGANIZED CRIME ACTIVITY WOULD BE THE MOTOR-CYCLE GANGS MENTIONED BEFORE AS ENGAGED IN THE DISTRIBUTION OF "SPEED."

THERE ARE NO MILITARY INSTALLATIONS IN LANE COUNTY. HOWEVER, THE U. S. AIR FORCE IS ATTEMPTING TO INSTALL AN ANTENNA NORTH OF EUGENE WHICH WILL BE PART OF A COMMUNICATIONS SYSTEM INTENDED TO PROVIDE CONTINUOUS CONTACT WITH STRATEGIC COMMANDS IN A NATIONAL EMERGENCY. THIS PLANNED CONSTRUCTION HAS PRODUCED A SIGNIFICANT NEGATIVE RESPONSE WHICH HAS BEEN REPORTED IN THE MEDIA. DEMONSTRATIONS ARE THREATENED IF THE AIR FORCE MOVES AHEAD WITH ITS PLANS.

THERE IS SOME POSSE COMITATUS ACTIVITY IN THE COUNTY.

REFERENCED BUREAU TELETYPE DID NOT INCLUDE MORROW COUNTY IN THE INQUIRY. HOWEVER, THERE IS A SITE IN THAT COUNTY WHICH HAS BEEN IDENTIFIED AS BEING OF INTEREST.
