BY CORRESPONDENCE DATED DECEMBER 23, 1959, OSI ADVISED THAT THE SUBJECT, [REDACTED] HAD TERMINATED HIS EMPLOYMENT WITH THE KAYNAR MANUFACTURING COMPANY, 7875 TELEGRAPH ROAD, RIVERA, CALIFORNIA (CA). THEREFORE, NO FURTHER ACTION WAS TAKEN REGARDING A SECURITY CLEARANCE FOR THE SUBJECT.
